- 2. Public Comment:** None.
- 3. August 20, 2021, Executive Committee Minutes:** *Jeanne Herman made a motion to approve the August 20, 2021, Executive Committee Meeting Minutes and Theresa Auld seconded. The motion passed unanimously.*
- 4. Nevadaworks Staff Wage Range update:** Milt Stewart explained that the Nevadaworks salary wage ranges had not been updated since 2017. Board Members, Theresa Auld, and Michelle Sanchez-Bickley, with staff prepared the updated 2022 Staff Wage Range document. *Jeanne Herman made a motion to approve the Nevadaworks Wage Range dated June 23, 2022, as submitted and Austin Osborne seconded. The motion passed unanimously.*
- 5. Program Year 2022 Budget:** Beth Wicks stated that the difference between the agenda item 5 and 6 is that the National Dislocated Worker Grants (NDWG) 1-year extensions had not yet been approved by the US Department of Labor or the State of Nevada. The NDWG Disaster Recovery funding is not included in item 5. This grant will end June 30, 2022, unless an extension is approved. The NDWG Employment Recovery funding is included but with an end date of September 30, 2022, unless an extension is approved. *Jeanne Herman made a motion to approve the Nevadaworks Program Year 2022 Budget as submitted and Theresa Auld seconded. The motion passed unanimously.*
- 6. Alternate Program Year 2022 Budget with NDWG DR funding:** Beth Wicks stated that this budget would only be used if the US Department of Labor and the State of Nevada approved a 1-year extension. *Theresa Auld made a motion to approve the Nevadaworks Alternate Program Year 2022 Budget with NDWG DR funding to be used if the US Department of Labor and the State of Nevada approve a 1-year extension for the National Dislocated*
